I the under signed have the honour to state that on 03/05/2023 at about 8:30 pm, some unknown persons holding arms with deadly weapons numbering about 1000 suspected to be Kuki community from different villages were entered at Sadu Yengkhuman village, Imphal East District, Manipur and started damaging properties and burning houses.

The following properties of my house were damaged in the incident.
