I went out from my house and saw the house burning up of 1 KOK, LEITANPOKO, I also heard that the houses of Meiteis were burnt by the militants, along with my family members left the house and took shelter at Sagolmang P.S. on the next day i.e. 9/5/23 at around 5:30 am we went back home but the said burki militants started burning our village now 9 others in the my daughter is staying with relief camp till today.
