

On 3/5/2023 in the evening, we were suddenly attacked by the Kuki inhabitants of the surrounding villages - Chayong, Chingdai, Phailenkot, Moljang, Chingmang & Thingjang - by firing several rounds of gunfire into our village. Earlier, we heard that Meitei inhabited villages nearby have also been attacked by armed Kuki militants and houses burnt. Fearing for our lives, we ran through the fields along with my entire family till we reached Tarotkhal around 11:00 pm of the same night. My husband remained behind to guard the village.
