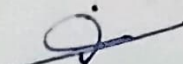

It is the tank of the our Kher village - Chayang, Chingdai, Hailantol, Meljang, Chingmang & Thingyang - started firing several rounds of gun fire into our village. We fled through the fields fleeing for our lives. My husband was carrying my 10yrs old father-in-law on his back till we reached Tareltahul around 11:00pm the same night.
