



I/E, about 265 in population were fled from our village as the kuki militants threat with firing to the innocent villager at mid night of 03/05/2023 at around 12:00 pm.


Thereby all the villagers were fled away for their safety and secure to different part of the state which lead to the anxiety hyper-tension and heart problem to many villager.


