It is therefore request you to kindly take up necessary legal action against the said Kuki millitants at the earliest.

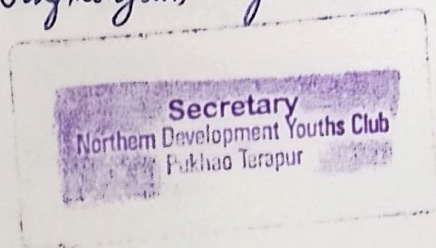


