To-day i.e. 28/06/2023 at 09 10 pm received an information that at around 09:00 pm of the same day some unruly mob numbering around 2000 persons comprising of men and women have started an unlawful assembly in violation of prohibitory order promulgated by the District Magistrate Imphal West vide order cril. misc case no. 7 of 2023 dated 27-06-2023 under sec. 144 Cr.PC at the courtyard of one Mutum Roben Singh aged about 50 years S/O. M. Irabot Singh of Chajing Awang Leikai as the news spread of his son Mutum Bobo was detained at Itham Moirangpurel for supplying material to Kuki communities during the ongoing communal clashes between Meitei/ Meetei and Kuki community. The mob became tense and violent and started to destroy his house and also burnt down some parts of the house & house hold items.

Hence a Suo-motu case under FIR No. FIR No. 428(6)2023 SJM PS, U/S - 147/188/448/457/436/427 IPC have been registered for investigation.
