

Sir,

I, T.Khamlianmang of Manipur University Campus, Canchipur, Imphal, am bringing to your kind notice that on the 3rd May, 2023 (in broad daylight) my residence was attacked by a group of Meitei mobs.

These goons immediately broke my compound gate and vandalised, looted and burnt down all my valuable properties within the house with the worth of Rs 6,44,900 (Six Lakhs Forty Four Thousands and Nine Hundreds) only. Amidst the criminal activities, I along with my family members managed to escape because of Divine Grace and fled to 1st MR (Manipur Rifle) for our safety on the 6th May, 2023.

Therefore, I request you to kindly take strong actions against the perpetrators by registering Zero FIR under relevant criminal sections of Indian Penal Codes.
