l, the undersigned would like to bring to the notice of your kind office my desire to formally file a FIR for the record of your kind office on account of the below ordeal underwent by me related to the 3rd May 2023 incident in our state of Manipur.

A few days after 3rd May 2023 (exact date could not be ascertained), during the raid of all Kuki-Zomi tribal occupancies within **Manipur University Campus**, miscreant(s) broke open the lock of my hostel/quarter room door, entered my room, and targetedly carried away my most important possessions, namely:

- 1. My grey colour file containing all my original documents including, but not limited to:
 - Marksheets, Admit cards, Provisional certificates, Graduation certificates, Migration certificates, Age proof certificates, Character certificates etc of Class X, XI, XII, B.Sc and M.Sc along with other documents related to the same educational qualification range, which I cannot recall.
 - ii. Award certification, Award letter etc of my qualified CSIR NET (Jrf) examination of December, 2019
 - iii. Birth certificate, Tribe certificate, Residence proof certificate, Domicile certificate etc
 - iv. All certificates of the various competitions/extra and co-curricular activities that I participated in from highschool to university levels.
 - v. SBI bank passbook
 - vi. Other original documents that I cannot recall at the moment.
- 2. My blue colour file containing photocopies of all the aforementioned original documents.
- 3. My external harddisk (1 Terabyte) containing priceless photos, videos, documents, files, including scanned photos of all my aforementioned original documents.

The loss of my above mentioned belongings have been undoubtedly confirmed by one of my PhD colleagues after physical inspection of my room.

Whether the miscreants burned the aforementioned articles to ashes or whether they kept it in their possession, one can only speculate, although it is more highly
