

Subject:- Complaint/Report.

Sir,

Most respectfully, I beg to submit the following brief report that took place on 16-06-2023 at around 08:30 pm to 10:30 pm, at Khagempalli Pankha Nganappi Thong, Imphal West for taking necessary legal actions by registering an FIR against the culprits/accused persons:

1. That, I am a business man by profession engaged in supply of raw materials (Natural Hair) for production of wig. As such I buy hairs from salons located in Manipur as well as from the neighboring state and transport the same to a dealer.
2. That, on 16-06-2023 one truck being Tata LPT having regd. No. AS 01NC 4327 registered under the name of one MR. N. Suresh Singh was transporting my raw materials (natural Hair) from Guwahati, Assam via Imphal to Thoubal.
3. That, on the way to the destination, at around 08:30 pm (16-06-2023) some unknown miscreants stopped the vehicle at Khagempalli Pankha Ngannappi Thong, Imphal west and checked the vehicle. After proper explanation to the unknown miscreants the vehicle was kept in the custody of the unknown miscreants.
4. That, however at around 10:30 pm the unknown miscreant unloaded the truck and burned the raw materials (Natural Hair) and the vehicles was handed over to the police, Imphal P.S.
5. That, it is pertinent to mention herein that the truck was carrying 40 bags of natural hair wherein each contains 30 Kgs of hair with the total of 1200 Kgs. That the natural hair was worth 75,60,000/- ( rupees seventy five lakhs and sixty thousands) only. (Copies o the Challan/invoice are enclosed herewith)

In the light of the facts and circumstances stated above it is therefore requested to register an FIR against the Culprits/accused persons for the ends of justice.

For this act of kindness, I shall ever remain grateful.
