Subject: Report of vandalised / burnt down and stolen of my properties.

I would like to report that, I am the contractor of PMGSY and working at Chandel Dist. from Serou (Longja) to Gonjil under work order no. PK No MN02130 since around 3 years ago. On the 3th May, 2023 large number of unidentified groups of people belonging to Kuki community with deadly weapons and sophisticated arms including kuki militants groups had stormed in our work site with a view to looting/vandalised/burnt down and attempt to murder of our workers. In that situation, I along with all the workers fled from my work site for saving our life but all the under noted construction machineries and items are abandoned in my work site. But, very unfortunately received information from the locality of my work site that, all the under noted items were looting /vandalised/burnt down on 6th May 2023 by them. My looting /vandalised/burnt down properties are:

It is, therefore requested you to kindly take necessary legal action(s) against those accused persons involved in the said inhuman acts and heinous crime committed as per law of the land at the earliest.
