I have the honour to report that on 27/06/2023 at around 04:56 pm, my Honda Activa 5G, Pearl Precious white in colour bearing registration No. MN06SC-8844, having engine No. JF92EG0040382 and Chassis no. ME4JF921GKG040306 was found stolen away by one unknown person while the said vehicle was parked in front of my gate. The approximate value of the stolen vehicle is about Rs. 70,000/- (Rupees seventy thousand) only. I could not report in time while searching the said vehicle and also couldn't produce the relevant documents of the said stolen vehicle.
