Subject: Report of vandalised / burnt down and stolen of my properties.

Su,

I would like to report that, I am the lawful attorney under Special Power of Attorney vide no 764895 sign on dated 20/04/2023 of one Special Class contractor of PMGSY namely Sheryo Hungyo (68 yrs) and working at IT Road to Geljang Kuki under Saitu Block under work order no. PK No MN06375 since around 3 years ago. In the intervening night of 3rd and 4th May, 2023, large number of unidentified groups of people belonging to Kuki community with deadly weapons and sophisticated arms including kuki militants group. had stormed in our work site with a view to looting/vandalised/burnt down and attempt to murder of our workers. In that situation, I along with all the workers fled from my work site for saving our life but all the under noted construction machineries and items are abandoned in my work site. But, very unfortunately all the under noted items were looting /vandalised/burnt down in the intervening night of 3rd and 4rd Mais. 2023 by them. The looting /vandalised/burnt.down properties are:-
