That, today i.e. 10/7/2023 at around 8:30 am, it came to know that some unknown persons had entered SSU, club located at Kakwa Bazar in between 3rd May, 2023 and 10/7/2023 at around 8:30 am and stolen away the properties of the Club's items i.e. one realme Smart TV, 4(four) wall fan, one computer printer, DVR of CCTV camera, one router, one wifi modem. Despite of several efforts whereabouts of the miscreants nor stolen properties could not be traced out till date. They also vandalised one CCTV monitor which was kept at inside the club.
