Sir,

Kindly refer to the above cited reference, I have the honour report that on 11/7/2023 at 11:00 ar received a report from one Yumnam Ushakanta Singh, Security-in-Charge, AIX Connect Pvt. Ltd. Imphal former known as Air Asia India Ltd. stating that on 11/7/2023 at 10:35 am, while scanning registered baggage at X-r. by their screener staff Mr. Y Xebec Singh (ASO), one passenger was found possessing some suspected contrabal items in their check in luggage. He was travelling to Delhi by flight 15-784(IMF-FAU) & 15-775 (GAU-DEL). It details of the detained passenger are: - (i) Mr. Punshiba Thoidingjam (23) s/o Th. Bharat Singh of Khagempa Panthak, Imphal West, near YOK Club. Possessing 4(four) packets suspected to be contraband items weight 2.58 Kgs. (approx.) with covering materials. Hence, an enquiry and endorsed to me for investigation.

Accordingly, I have informed the SDPO-SJM to be present during the seizure procedure. Then, a tea of Singjamei Police led by me rushed to the spot. As soon as we reached at the spot i.e. AIX Connect Pvt. Lt Imphal baggage scanning area inside Imphal International Airport, one detainee namely Mr. Punshil Thoidingjam (23) s/o Th. Bharat Singh of Khagempalli Panthak, Imphal West, near YOK Club. Possessing 4(Ion packets suspected to be contraband items weighing 2.58 Kgs. (approx.) with covering materials along with or trolley bag red in colour was found at the spot guarded by the staff of AIX Connect Pvt. Ltd. Imphal along wi CISF Security personnel.

The said trolley bag was opened in presence of SDPO-SJM and the staffs of AIX Connect Pvt. Lt Imphal. On opening the trolley bag red in colour marked as "Magnum" which belongs to Punshiba Thoidingia found 4(four) packets of suspected Ganja i.e. (i) one packet containing contraband item suspected to be gar inside a black polythene zapper wrapped with pencil carbon and adhesive transparent saluted weighing 0.41 gms marked as "A", (ii) one packet containing contraband item suspected to be ganja inside a black polythezapper wrapped with pencil carbon and sulay fried fish cover red in colour weighing 0.640 gms marked as "I (iii) one packet containing contraband item suspected to be ganja inside a black polythene zapper wrapped wi pencil carbon and sulay fried fish cover red in colour weighing 0.620 gms marked as "C" and (iv) one pack containing contraband item suspected to be ganja inside a black polythene Zapper wrapped with pencil carb and sulay fried fish cover red in colour and adhesive transparent saluted weighing 0.820 gms marked as "! Altogether weighing 2.56 Kgs.(approx.) including the weight of packaging materials.

Hence, the detected Ganja found from the possession of Punshiba Thoidingjam i.e. 2.56 Kgs.(approincluding the weight of packaging materials marked as "A", "B", "C" and "D" along with one trolley bag red colour marked as "Magnum" were seized by preparing proper seizure memo in presence of the witnesses 11:50 am and he was arrested at the spot at 12:10 pm by observing proper formalities.

The seized items along with the arrested person is handed over to you for taking up further leg

action.
