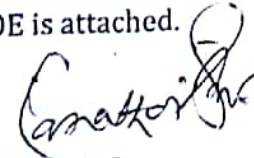

I Patrick Kamalgou Lengen studying in
Manipur Institute of Technology which is under
Manipur University beg to state about the
fateful night of attack.

I was staying at MIT Men's Hostel (Hostel no. 7)
Room number 306 which is inside the
Manipur University campus.

It was the third (3rd) of May, 2023.
I had just returned from college and went
out to buy some groceries outside the university

1/ at around 3:30 to 4:00. When I came there are some people gathered at the traffic Island which seems to be people from the locality burning things just in front of the MU (Manipal University) main gate.

Not long after I reach my hostel, I hear the news that the meitei mobs are searching for Kuki students inside the MU campus and I came across a viral video of a meitei guy ~~taking~~ recording saying they (the locality meitei people) are ~~going~~ ^{about to go} inside the MU campus and in search of Kuki students.

In our hostel there are As I was the senior most batch in the host (MIT men's hostel) I gathered all my kuki colleagues and juniors and we stay together. ~~and after~~ Around 7:30 we started hearing the mobs shouting and coming towards our hostel side. There are many hostels ~~in front~~ (most of them are girls hostels) before our hostel as our hostel (MIT Men's hostel) is at the last corner of MU campus. We can hear the sound of the meitei mob attacking girls hostel ~~as~~ from a distance and shouting "Kuki ~~libero~~ student libero" which means

here Kuki students ~~came~~ as they
pleas. ~~at~~ that they ~~came~~ as they
can see the mob ~~about~~ more than
not attacking MIT girls hostel. As after
that they attacked ~~one~~ boys hostel which is
in front of our hostel and another one next to
our hostel. After that they came to our hostel
and try to attack but they weren't able
to enter as we lock the main gate of our
hostel. They throw stones at our hostel and went
back and started attacking MIT girls hostel again.
This time they entered ~~through~~ inside the MIT girls
hostel. The ~~staying~~ ~~staying~~ of the mob and hostellers can
be heard from my

As we were staying helplessly in our hostel,
some of my friends send me the contact no.
of an army officer ~~which~~ ~~parting~~ in the army
camp inside the MCI campus and told me to
contact him as he was rescuing Kuki students
inside from their hostel, to army camp.
we contacted him and we were rescued by
him ~~and~~ the army and stayed in their camp
for the night. In the morning around 4:00 AM
we were shifted to 1st MR relief camp. He stay

the airport by the army. ~~we~~ we were drop
was on the 8th of May but me, my younger
sister (who is also a hosteller of MIP girls hostel) and
my aunty just got on the army vehicles as
our only thought was to reach the airport
as it is safer and heavily guarded by the
paramilitary forces. ~~As there~~ ~~we~~ ~~don't~~ ~~even~~ ~~think~~
We stayed for two nights at the airport. Our
family ~~from~~ ~~outside~~ who stayed outside Manipal
booked the flight ticket and we took the
flight and landed in Guwahati. After that we
went to Shillong and stayed at our relative
house.

On the 4th of May, as we were still at 1st MR
relief camp I was inform by one of my friend
that my vehicle (A10 K10, red colour, bearing ~~no.~~ ~~no.~~
no. :- MN0152846) ~~was~~ ~~burnt~~ and my study material
clothes, electronic devices, etc which is a & I have
left it in my hostel were ~~burnt~~ all burnt.

I am hoping for Justice and for all who are
in this situation and to book the culprits as per
sections of the Law.
