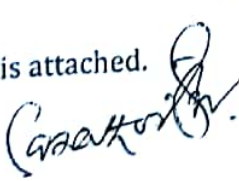

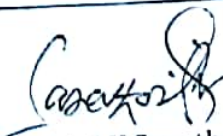

Respected Sir,

I Judith Lamhoihing Lengun, studying in Manipur
Institute of Technology which is under
Manipur University beg to state about the
fateful night of attacked.

I was staying at MIT Girls Hostel (Room No.-130
which is also inside Manipur University.

It was the 3rd of May 2023.

I had just returned from home after a brief
period of continuous holidays, it was 4pm and
nothing seemed to happen anywhere.

But then suddenly news of riots came crashing
down the internet like burning of houses.

At around 7pm, we heard that there will be
attack on Manipur University and after some
times we saw some videos of burning things
in front of the gate in whatsapp groups.

of miscreants roaring in the atmosphere & In a minute I heard sounds of the miscreants shouting "where are the Kukis?" over those Kukis to us". in front of our host. They tried to break the gate but they couldn't enter through the back gate. Our seniors hid us in one room, we off the lights and we (Kuki girls) hid under the bed. They checked all the rooms and they even break the doors which are closed. They started knocking the door which we Kuki people hid. Some of seniors were standing at the ^{door} pushing ~~they~~ their best not to open but they couldn't so they open the door. They enter ~~and~~ checked everywhere and they saw us hiding under the bed. They asked ~~whether~~ whether we are K or not, we lied and said we are 'Plaga'. they left us. They Mier mob who came to attacked us were about more than 300. they were wearing black t-shirt at the same time I could see them holding sticks and iron rod which was big enough to attack someone and kill.

After some times, the Assam Rifles came for rescuing all of the Kuki Hostellers because only Kukis are targeted. They provided us a refuge in their camp and in the following morning we were shifted to 1st MR Camp at Old Lambulane and we stayed there for 2 days with no proper food, no drinking water and no sanitation.

There were no security of staying in Manipal, so, my uncle booked a ticket to Shillong. Sudith Lengh.

I thought that 1st MR would not be safe as
there is no proper security.

We went to Airport 2 days prior to our
booked flight tickets. I felt a relief when I
saw Indian Army posted at airport.

We somehow managed to sleep on the floor
of the waiting hall for 2 days.

On the next day, we reached Shillong safely
by the Grace of God. After reaching Shillong,
I was still in panic attacked for the past
few days due to my traumatic experience.

We are hoping for Justice for us and for all
who are in this situation and to book the
culprits as per sections of the Law.

I request you to provide me as I'm in dire
need of assistance.
