I, the undersigned would like to bring to the notice of your kind office my desire to formally file an FIR for the record of your kind office, on account of the below ordeal underwent by me related to the 3rd may 2023 incident in our state of Manipur. On the 20th June 2023 a group of Meitei miscreants, in their continue passionate effort to wipe out every single remaining trace of KUKI-ZO tribal presence in the valley, entered my rent building, broke into my room and looted every single piece of property from my room, including my two wheeler scooter and my bicycle, both parked in front of our building at Langthabal, Canchipur, P.S.- Singjamei, Imphal East. Below is a list of items confirmed to have been looted and taken away including my research materials:

1. Aprilia bike bearing number MN01AF3084. Net worth Rs. 1,50,000 approx.
2. Laptop dell, keypad, mouse, pen-drive, headphone, speaker, etc. Net worth Rs. 1,90,000 approx.
3. Bicycle and its accessories. Net worth Rs. 40,000 approx.
4. Soil respirometer, microscope, soil thermometer, chemical and other Lab equipment; etc. Net worth Rs. 2,30,000 approx.
5. Mountain boots, formal shoes, coat suit, lab clothes, sneakers, Binoculars and other clothes. Net worth Rs. 1,80,000 approx.
6. Kitchen utensils, gas stove, cylinder, light cooker, cooker etc. Net worth Rs. 80,000 approx.
7. Beds, table, chair, Almirah, music stand, wardrobe, mattress, blankets etc. Net worth Rs. 1,10,000 approx.
8. Academic books, Research papers, Competitive Books, etc. net worth Rs. 60,000 approx.
9. Certificate, Documents, Pan card, University Identity Card, Vehicle Licence Card, etc.

I have meticulously calculated my material loss to be in tune of Rs. 10 lakhs approx.

I therefore request your kind office to seriously look into the matter and file FIR of the incident and take necessary actions.
