Subject:- Report on looting, vandalism and burning of Church building and its properties.

Sir,

I, the undersigned, have the honour to state the following for your kind intervention and favourable action praying for registering an FIR and investigate the matter by due process of law:

- That, I Shri. Maj. TC Thanga, Divisional Commander, The Salvation Army, Eastern Division, Churahandpur, and hereby competent and authorise to file a complaint on behalf of the Church.
- 2. That, at about 10:00 am on the 4th of May 2023, some armed radical mobs belonging to the meetei/meitei community armed with sophisticated weapons, suspected to be members of Arambai Tengol and Meetei Leepun, aided by state forces like Police commando, IRB and Manipur Rifles posted at various valley based police outpost chanting anti-tribal slogan, broke open the gate of the said Church premise and burnt/torched/gutted, several church buildings details of which are given as under;
 - (i) Kwakeithel Salvation Army Church Building Situated at Kwakeithel, Imphal West, P.S. Imphal City. 1 P.S
- (ii) Chairel Salvation Army Church Building and Church Guest House, situated at Chairel Khunou, P.S. and District Kakching, Manipur Sagara PS and all what is within the above mentioned structures and all what is within the said premise a total estimate value of Rs.29,05,200 (Rupees Twenty Lakh Five Thousand Two Hundred) Only was all lost due to the illegal activities of the said armed miscreant.

That, in view of the above stated facts and circumstances, being a victim of a communal/ethnic clash spearheaded by the majority meetei/meitei community. I see filing this report on behalf of the Church, with a request to kindly take necessary legal action against the perpetrators as per law.
