Sir,
I, the undersigned, have the honour to submit that a large numbers of kuki community with deadly weapons and sophisticated arms including kuki militant group (s) stormed and open fired, threatened to kill to all Meitei/meetei inhabited area (s) of Leitanpokpi and looted all movable properties on 3rd May, 2023 at about 8.00 p.m.. In that unfortunate incident, my family are fleeing our village and now my family is taking shelter at a Relief Camp, Pangei Yangdong, Imphal East.

I, therefore, request you to kindly take up necessary action with lodging F.I.R. against the kuki culprits at the earliest.
