



I, the undersigned, have the honour to submit that a large numbers of kuki community with deadly weapons and sophisticated arms including kuki militant group (s) stormed and open fired, threatened to kill to all Meitei/meetei inhabited area (s) of Leitanpokpi and looted all movable properties on 3<sup>rd</sup> May, 2023 at about 8.00 p.m.. In that unfortunate incident, my family are fleeing our village and now my family is taking shelter at a Relief Camp, Pangei Yangdong, Imphal East.

I, therefore, request you to kindly take up necessary action with lodging F.I.R. against the kuki culprits at the earliest.
