Today i.e. the 18th June'2023 at 02:00 am received reliable information that in between 9:30 pm of 17/07/2023 and 1:50 am of 18/07/2023, large numbers of unruly mob comprising of men and women mainly womenfolk have unlawfully assembled at the main road of Singjamei Chingamakhong crossing along NH-102, violating the order passed by District Magistrate, Imphal West for imposing 144 Cr.PC. The unruly mob becomes more violent. Accordingly, the RAF and Police personnel present at the spot have tried to disperse the unruly mob by using non-lethal means. However, the unruly mob turned to the Police. They vandalized and burnt down Police booth installed at Chingamakhong crossing.

Hence, a suo-motu case under FIR No. 475(7)2023 SJM-PS U/S 147/149/188/152/427/435 -IPC has been registered for investigation.
