

Subject: **FIR on attempt to Murder.**

Sir,

With due respect, I the undersigned would like to make a report to your good office about the attempt to murder committed by the Meitei mob while I was inside my room at Manipur University B&P.S. Singjamei District Imphal West on 3rd May, 2023.

At the very outset, I would like to draw a few-line for your information that in the intervening day some mob (Meitei) entered our Ladies Hostel M.V. at around 5 PM - 3 AM and they were searching for any Kuki/Zo people residing there while they were shouting anti tribal slogans like 'Hao Hatlo' /Kuki Hatlo. Fortunately, I managed to escape from these criminals who tried to kill/burn me alive.

I request you to take strong actions against the perpetrators by registering a FIR/ZERO FIR under relevant criminals' provisions of law.
