I the undersigned have the honour to state that on 19/05/2023 at about 12:40 pm, some unknown persons holding arms with deadly weapons numbering about 50 suspected to be Kuki community from different villages were entered in my house located at Dolaithabi Maning Leikai and started damaging properties and burning.

The following properties were damaged in the incident.

1. Ou akhaiba 200 kb worth about Rs. 1,40,000/-
2. One shingei Rs. 25,000/-
3. Firewood of two truck – Rs 70,000/-
4. Sintex 3 nos. of 500 Ltrs mark as Leima – Rs 7,000/-

I therefore, request to kindly taken up further legal action against the above unknowns persons.
