



I the under signed have the honour to state that on 03/05/2023 at about 10:10 pm, some unknown persons holding arms with deadly weapons numbering about 1000 suspected to be Kuki community from different villages entered in my grocery shop "Echanbi Dukan" located at Leitanpokpi Awang Leikai, Imphal East District, Manipur after knock down log & key and looted grocery items and cash.

The following grocery items which were looted from my grocery shop in the incident are:

1. On cash - Rs. 50, 000/- (Rupees fifty thousand)
2. Grocery items - Rs. 2, 50, 000/- (Rupees two lakh fifty thousand)

Total - Rs. 3, 00, 000/- (Rupees three lakh)

I couldn't report the matter in time as I along with my family members are taking shelter at Khurai Angom Leikai relief camp.

I therefore, request to kindly taken up further legal action against the above unknowns persons.


