With reference to the above cited subject, I have the honour to report to you as follows:

- 1. That, I am a Scheduled Tribe belonging to the fly Lyki. Tribe, which is a recognized Tribe under the Constitution of India, by virtue of which I am being entitled to the protection under The SC/ST (Prevention of Atrocities) Act, 1989. That, I am a student of Manipur University, Canchipur, P.O. & P.S. Singjamel, Imphal West District and a resident of MU Hostel + NO S
- That, on the 3rd May, 2023, at about 7:0 MAM/PM, the Meitei/ Meeteis 2. radicals suspected to be members of the Arambai Tenggol and Meitei Leepun were all over the Campus at Manipur University, Canchipur, Imphal in search of Students belonging to KUKI/ZO tribes.
- 3. That, it may be reported here that the miscreants were shouting slogans like-"KANGLEIPAK YAIPHARE"; "KUKI HATLO"; "HAO HATLO"; etc. while they were carrying out their criminal activities. It seems to me that all these has taken place at the instance of the Manipur State Government as the perpetrators openly claimed and shouted that nobody would stop them, even the police because everyone, including top officials of the Manipur Government are patronizing them and that that no harm could be done to them.
- 4. That, at the time of the attack we somehow managed to escape to save our lives under the compelling circumstances and thus could not take our belongings including important documents like Aadhar Card, ATM Card, PAN Card, educational certificates, etc. apart from other tangible materials. A list of our properties looted/ destroyed/ burnt is attached here under with its estimated costs. The total loss suffered is estimated to be about Rs. 70000 (Rupees Swinty Chorumal

.....) only. This report is treated as an OE of case FIR NO. 486 (7) 2023 SUM PS U/S 143/148/307/427/397/34-18C.3 of PDPP Act & Sec 3 (2) (iii) of SC & ST (Premerition of Atrocities) Act. Ler-Live Change Singjamei Police Station

In the given circumstances, I humbly pray you to kindly register an FIR/ ZERO FIR, investigate the matter and punish the perpetrators as per the prevailing provisions of the laws of our country. And, for which act of kindness, I shall always remain thankful to you and obliged.
