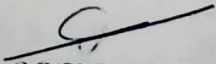

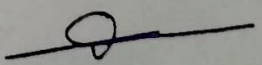

The following properties of my house were damaged in the incident

- (1) House 1 - 250000.
- (2) Kitchen house (1) - 1,25000.
- (3) Iron clothes (1) - 30,000.
- (4) Almirah (1) - 80,000
- (5) Bed (Kandhong) (1) - 150,000
- (6) Clothes - 65 100000
- (7) Kitchen item - 30 - 10,0000.

Total Amount 835,000.

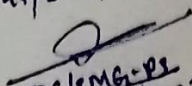
