- That, I am a Scheduled Tribe belonging to the Annual Tribe, which is a recognized Tribe under the Constitution of India, by virtue of which I am being entitled to the protection under The SC/ST (Prevention of Atrocities) Act,1989. That, I am a student of Manipur University, Canchipur, P.O. & P.S. Singjamei, Imphal West District and a resident of MU Hostelf Ladiu Remarch Cohelan No. 4 Room No. 306
- 3. That, it may be reported here that the miscreants were shouting slogans like-"KANGLEIPAK YAIPHARE"; "KUKI HATLO"; "HAO HATLO"; etc. while they were carrying out their criminal activities. It seems to me that all these has taken place at the instance of the Manipur State Government as the perpetrators openly claimed and shouted that nobody would stop them, even the police because everyone, including top officials of the Manipur Government are patronizing them and that that no harm could be done to them.
- That, at the time of the attack we somehow managed to escape to save our lives under the compelling circumstances and thus could not take our belongings including important This report is treated Study material, gooks, articles, Archive materials, etc. apart as an OF of Case FIR NO. 490(7)2023 from other tangible materials. A ust or our properties looted/ destroyed/ burnt is attached (341/EH1 . 2/U, 29 mEZ 367/427/397/436/ here under with its estimated costs. The total loss suffered is estimated to be about 34-IPC 30 PAPP Rs. 20000 (Rupees Twenty Choujand Act & Sec 3/2) (iii) of .....) only. SC \$57 (Prevention of Alrocities ) Acts.

In the given circumstances, I humbly pray you to kindly register an FIR/ ZERO FIR, investigate the matter and punish the perpetrators as per the prevailing provisions of the laws of our country. And, for which act of kindness, I shall always remain thankful to you and obliged.
