

SUB :- FIR (FIRING INCIDENT)

Sir,
On DTD 26-05-2023 AT 1610 HRS heavy fire started at Southern side ridge of jungle at Sadhulampak Leitanpokpi side on Manipur rifle post . BSF ADP cum MCP party also positioned on the same road . BSF QRT party moved to cover own troops while reached near Leitanpokpi Likli bridge came under fire from Hill ridge. BSF QRT headed by Sh. R.S. Pundir, AC a/w sos 01, ors 12 total 14 retaliated the fire to cover its own troops ~~safe~~ and fired 13 RDS of AKM and 04 RDS 5.56 mm x-95 Rifle total 17 RDS comma 05 NOS EFC traced and 08 NOS EFC of AKM are missing so far . Operation called off at 261800 hrs in all respect . Details of firer are as under . One Irla No 41837559 Sh. Randhir Singh Pundir, AC Coy Comdr with AKM butt No 01 body No. AB44-7555 RDS fired 11 Nos, Two Regt. No 112436889 CT Surendra Sunagar with AKM butt No 08, body No BE 44-8688 RDS fired 02 Nos Three Regt. No 124504208 CT Rupak Kumar with RFL X-95 butt No 16, body No 40824300 RDS fired 04 Nos total RDS fired 17 Nos. Total EFC found AKM 05 Nos missing 08 Nos , 5.56 mm EFC found 04 Nos missing nil . Distance of firing place from BSF Leitanpokpi police out post appx 1.5 km, distance from BSF ADP cum MCP point appx 400 mtrs.
