On dated 28/05/2023 at about 0445 hrs I received information from our MCP deployed at Sadulamapak village that firing shots are heard in the other side of the village Saidulampak and some houses are being burnt by the suspected Kuki miscreants. I immediately rushed at the place of incident at village Sadulampak along with my following troops


