In such terrorist act, some unknown Volunteers / villagers got serious injuries on their person at Leitanpokpi Nahakpam Loukon, Sadulampak and nearby villages Imphal East District, Manipur while rescuing the victims.

Hence, a suo moto case has been registered under FIR No. 495(5) 2023 SMG-PS, u/s. 427/435/447/506/307/326 IPC, 16 (1) (b) /20 UA(P) Act and 25(1-C) Arms Act.
