In which, one Shri Sagolsem Budha Meitei 37 yrs s/o. Sagolsem. Bimol Meitei of Leitanpokpi Maning Leikai got serious injuries on his person and later on evacuate to JNIMS Hospital, Porompat for medical treatment.

Hence, a suo moto case has been registered under FIR No. 497(5) 2023 SMG-PS, u/s. 506/307/326 IPC, 16 (1) (b) /20 UA (P) Act and 25(1-C) Arms Act.
