
Again at 301300 hrs heavy volume of fire started from jungle side on Post Letianpokpi in retaliation of fire Morcha No. 01 firer no 04544017 CT Babula Barman fired 53 RDS with 5.56 MM INSAS LMG butt No. 03 body No 16562030 out of which 49 EFC found and 04 Nos EFC are missing, Morcha No. 02 firer No. 111871234 CT Sunil Mahto fired 25 RDS with 5.56 MM LMG butt No. 07 body No. 169631779 out of which 23 EFC found and 02 EFC missing total RDS fired 78 EFC found 72 Nos EFC missing 06 Nos firing stopped at 301345 hrs.



R.S. Pundir, AC Coy Comdr A/W 09 ors fired 02 Nos 51 mm HE bomb fired by No. 112436889 CT Surendra Sunagar with 51 MM mortar butt No. 02, body No. 007037. Total RDS of 5.56 mm fired 234 Nos, 51 mm HE bomb 02 Nos, due to darkness EFC still not recovered. Fire stopped at 302010 hrs.




