On 31-05-2023 at about 0400 hrs heavy volume of fire started from jungle side on Police Post Letianpokpi and in mean time also on our NDP cum ambush party led by SI Shashi Bhushan Das deployed at Village Sadu Lampak side. Retaliation of fire, Morcha No 01 firer No. 134209241 CT Rais Ahmed fired 55 RDS with INSAS LMG butt NO. 03 body No. 16562032, from Morcha No. 02 fire No. 214205660 CT Bhavtosh Kumar fired 61 RDS with INSAS LMG butt No. 07 body No. 16451779, from NDP cum ambush party No. 12101124 CT Balram Kumar & No. 14330220 CT Santosh Singh fired 24 RDS with 5.56 mm INSAS LMG butt No. 02, body NO. 16765821 and No. 11187113 CT Parimal Mandal, No. 11121525 CT Matiur Rahman fired 51 RDS with 5.56 mm INSAS LMG butt No. 17, body No. 16822780. Total RDS fired 5.56 MM RDS 191 Nos EFC recovered 128 Nos EFC missing 60 Nos. Fire stopped at 310630 hrs. No loss of men and material reported.


You are requested to file FIR against the unidentified miscreants/ insurgents who fired on the BSF troops .




