Subject: Report on Criminal Intimidation, Sedition, Attempt to murder, outraging the modesty of women, promoting enmity between community, disturbing public tranquillity, burning and looting of personal assets.

Madam,

I, the undersigned, have the honour to state the following for your kind intervention and favourable action praying for registering an FIR and investigate the matter by due process of law:

1. That, I Miss Lhaideichong Haokip D/o Letkhai Haokip, belonging to the Any Kuki tribe/community, a Schedule Tribe recognized under the Constitution of India, by virtue of which I am entitled to the protection under **The SC/ST (Prevention of Atrocities) Act, 1989.**
2. That, I am a permanent resident of Tuibuong, P.O./P.S. & District Churachandpur, Manipur-795128
3. That, I am a student currently pursuing my Master programme at Manipur University, Situated at Canchipur, P.O./P.S. Singjamei, Imphal East, Manipur-. residing at a rental room situated at Langthabal Awang Leikai, near Manipur University, P.O./P.S. Singjamei, Imphal East, Manipur.
4. That, on the 3rd of May, 2023 at about 9:30 pm some armed radical mob belonging to Meetei Community spearheaded by the infamous Meetei Leepun and Arambai Tengol knock on each and every door within our vicinity chanting anti tribal slogan and slogan outraging the modesty of a tribal women with an intent to kill.
5. However, fortunately I am able to survive the haunting tragedy despite all hurdles and against all odds, reached my native resident mentioned herein-above.
6. That, the said mob on reaching my rental room destroyed, vandalised and burnt all what was left at the said rental room, a lost estimated to be at an amount of Rs. 200000/- (Rupees Two lakh Only) approximately.

That, in view of the above stated facts and circumstances, being a victim of a communal/ethnic clash spearheaded by the majority meetei/meitei community, I am filing this report with a request to kindly take necessary legal action against the perpetrators as per law.
