In which, the unknown angry youths suspected to be Meitei community entered at C Joulen village and its adjoining villages (Thingjang, Chingdaikhullen, S. Philenkot, L. Changjang, & S. Langhoi, and attacked by opening fired using armed and vandalized household properties and also burnt down some houses.

Hence, a suo moto case has been registered under FIR No. 500(5) 2023 SMG-PS, u/s. 147/148/149/427/435/34 IPC.
