

That, I Thanglal Jam aged about 23 years, s/o kai samy Lal, belonging to the uniphei tribe/community, a Schedule Tribe recognized under the Constitution of India, by virtue of which I am being entitled to the protection under The SC/ST (Prevention of Atrocities) Act, 1989. and that, I am a permanent resident of Langthabal kunjawang, P.O./P.S. Singamei, Imphal West District, Manipur-795_____.
2. That, at about 7:00 am/pm on the 3rd may, 2023, a huge contingent of armed radical Meeitei/Meitei suspected to be members of the Arambai Tengol and Meetei Leepun along with attacked our rented house at Langthabal and in the process, they have looted, vandalized and torched my properties & Educational document
3. That, it may be reported here that the above said criminal activities have caused grave mental agony and incurred huge loss which resulting in the missing of my documents listed here as hereinunder
