I the under signed have the honour to state that on 28/05/2023 at about 10:10pm Some unknown persons holding arms with deadly weapons numbering about 1000 suspected to be kuki community from different villages were entered at Moreh, Chandel district, Manipur and started damaging properties and burning houses.

The following properties of my house were damaged in the incident.

1. One House(Pucca House G+1, Five room in each floor) +(G-1,oil and lubricant store)+2 Pucca toilet and 1 bathroom
