

Today i.e. the 23<sup>rd</sup> July'2023 at 03:40 pm, received a reliable information that on the same day at about 03:30 pm, one Honda Activa, red in colour bearing Regn. No. MN01U-5311 ridden by unknown rider plying from North to South direction met a sideswipe accident with one vehicle XUV-500 car, white in colour bearing registration No. MN01AK-7460 driven by unknown driver plying at the same direction while trying to overtake at Kakwa Nameirakpam Leikai along NH-102 due to rash or negligent driving on the part of both the driver of XUV-500 and rider of Honda Activa. As a result of which, the rider and pillion rider of Honda Activa received injuries on their persons and evacuated to Hospital for Medical treatment and both the vehicle were also partly damaged.

Hence, a Suo-Motu case under FIR No. 504(7)2023 SJM PS, U/S 279/338/427 -IPC has been registered for investigation.
