I the under signed have the honour to state that on 28/05/2023 at about 4.00AM some unknown persons holding arms with deadly weapons numbering about 200 suspected to be Kuki Militants from different villages were entered at Leitanpokpi Sadulampak village, Imphal East District, Manipur and started open fired, damaging properties and burning houses.

Sir,

The following properties of my house were damaged in the incident.

1. One House:- Rs. 4,00,000 (Four lakhs)
2. Cash amount:- Rs. 1,00,000 (One lakh)
3. Gold San :- 8.5 gms - Rs. 1,20,000 (One lakh twenty thousands)
4. Paddy bags:- 50 bags - Rs. 50,000 (Fifty thousands)
5. Other house hold properties:-
 - a. 1. Granary - Rs. 1,00,000 (One lakh)
 - b. House making wood - Rs. (70,000) Seventy thousands
 - c. 8-cows - Rs. 2,00,000 (Two lakhs)
 - d. House hold properties - Rs. 250,000 (Two lakhs fifty thousands)

The above damaged properties is estimated to worth about Rs. 12,90,000 (Twelve lakhs ninety thousands)

I therefore, request to kindly taken up further legal action against the above Unknowns' persons.
