I the under signed have the honour to state that on 28/05/2023 at about 4.00AM some unknown persons holding arms with deadly weapons numbering about 200 suspected to be Kuki Militants from different villages were entered at Leitanpokpi Sadulampak village, Imphal East District, Manipur and started open fired, damaging properties and burning houses.

The following properties of my house were damaged in the incident.

1. ^{Two} One House:- Rs. 8,00,000. (eight lakhs).
2. Cash amount:- Rs. 2,00,000. (Two lakhs)
3. Gold San :- ... 8 Sams ... Rs. 90,000. (Ninety Thousands)
4. Paddy bags:- 100 bags:- Rs. 1,00,000. (ONE lakhs)
5. Other house hold properties:-
 - a. 1. Granary - Rs 1,00,000 (one lakhs) @ 1 Rotavator - Rs 2,00,000 (Two lakhs)
 - b. 1. power tailer - Rs 2,00,000 (Two lakhs)
 - c. 1. Santro car - Rs 1,60,000 (one lakhs sixty thousands)
 - d. 1. Thrashet machine - Rs 2,50,000. @ 6 Cows - 1,60,000. @ 7 pigs Rs. 78,000.

The above damaged properties is estimated to worth about Rs. 26,88,000. (Twenty six lakhs eighteight thousands)

I therefore, request to kindly taken up further legal action against the above Unknowns' persons.
