Subject:- Request for initiating necessary legal action against the 2/8 GR  
Personnel.

I am to report that today i.e 12/06/2023 at about 1:00 pm received a creditable information that there were exchange of heavy fire between Kuki militants and some Meitei youths at the Eastern Hill side of Pukhao Shantipur. Then, self with party along with a team of Reserve line, Imphal East proceeded towards the said location. When we were proceeding along Pungdongbam Dolaithabi road, we were stopped by a column of 2/8 Gorkha Regiment personnel restraining us from proceeding further at Taretkhul parking, Imphal East, District, Manipur at about 1:25 pm. I alighted from my vehicle and asked the Gorkha Regiment personnel the purpose of preventing us from proceeding further and obstruction to lawful discharge of duty. In that, they replied that they were prevented to move further by the womenfolk of the area and further stated that they would not allow us to proceed further. Then, I disclosed my identity to the officer and I am proceeding towards Eastern Hill side of Pukhao Shantipur to discharge my lawful duty. Meanwhile, 5/6 Army personnel stood in front of my vehicle, the womenfolk pushed the Army personnel who were standing in front of my vehicle. Then, my driver started to drive my vehicle, that time the Army officer ordered one of his personnel to fire upon my vehicle. Then the personnel fired upon my vehicle, in that, one of the bullet hit the left side of Headlamp of the vehicle, another passed through my seat. After some time, it is ascertained that one of the bullet grazed on the left hand of my escort.


It is requested for taking necessary legal action against the Gorkha Regiment personnel.
