Subject: Report for registering an FIR and causing appropriate inquiry/investigation to book the culprits under the law for serious criminal acts.

Sir,

I the undersigned, a villager of Sadu Lampak, Imphal East under your jurisdiction submits this report of a series of criminal acts for causing necessary inquiry and investigation to book the culprits under the laws of the land.


1. That on 28<sup>th</sup> May, 2023 in between 3.30 am to 8.00 pm suddenly a number of armed militants allegedly Kuki militants now under SoO with Government of India and Government of Manipur, supported by a large number of Kuki villagers attacked the unarmed villagers by firing from automatic weapons forcing all of us including myself to flee from the place to save our lives. They then, besides looting set on fire everything in the village, and all our properties including standing properties, dwelling houses, movable properties, live-stocks, were reduced to ashes as we had to flee to neighbouring villages and thence to the relief camp opened in Leitanpokpi Relief Camp and living on the charity of philanthropists.
2. The detail of the losses suffered by me is attached in a separate enclosure. The total value of the property lost was estimated to be about Rs...../-
3. In the above circumstances, it is humbly requested that necessary investigation may be conducted at the earliest to book the culprits under the laws of the land for looting, attempting to murder, using unlicensed automatic weapons, destroying all properties and bring them to justice.

I, the undersigned will be grateful if necessary action is taken up from your end without delay.
