2023 at around 07:00 P.M the said unidentified groups vandalised/burnt down my  
house/shop and looted all valuable items. In that unfortunate incidents I have lost a total  
amount Rs. 10,00,000/- (Ten Lakhs only, furniture and household)

After the said unfortunate incident/mob violence my family are fleeing our village and my  
family is taking shelter at a relief camp (2MA CHINGJROI BI RELIEF CAMP)

It is therefore prayed that the respected Sir may kindly Initiate and take necessary legal  
action(s) against the accused persons and the persons involved in the said inhuman acts and
