Sir,

I the under signed have the honour to state that on 28/05/2023 at about 7:00 am, some unknown persons holding arms with deadly weapons numbering about 200 suspected to be Kuki Militants and Kuki community from different villages entered at Dolaithabi village, Imphal East District, Manipur and started damaging properties and burning houses .

The following properties of my house were damaged in the incident.

1. Two Houses burned – Rs. 4,00,000/- (Rupees Four lakhs).
2. Kot (Granary Storage house) – Rs. 2,00,000/- (Rupees Two Lakhs).
3. Kitchen House – Rs. 1,00,000/- (Rupees One Lakh).
4. Paddy bag (70 bags)- Rs.70,000/- (Rupees Seventy thousands).
5. Carpenter tools- Rs.1,30,000/- (Rupees One Lakh Thirty Thousands).
6. Cattle and Poultry animals – Rs.2,00,000/- (Rupees Two Lakhs) and
7. Other house hold properties – Rs. 5,00,000/- (Rupees Five Lakhs).

The above damaged properties is estimated to worth about Rs. 16 lakhs.

I therefore, request to kindly taken up further legal action against the above unknowns persons.
