Sir,

I the under signed have the honour to state that on 28/05/2023 at about 7:00 am, some unknown persons holding arms with deadly weapons numbering about 200 suspected to be Kuki Militants and Kuki community from different villages entered at Dolaithabi village, Imphal East District, Manipur and started damaging properties and burning houses .

The following properties of my house were damaged in the incident.

1. One House burned – Rs. 6,00,000/- (Rupees Six lakhs),
2. Paddy bag (80 bags)- Rs.80,000/- (Rupees Eighty thousands),
3. Rice Mill - Rs.30,000/- (Rupees Thirty Thousands),
4. Power Trailor – Rs. 1,50,000/- (Rupees One Lakh fifty thousand),
5. Kamco Kabota – Rs.2,00,000/- (Rupees Two Lakhs),
6. Electronics items- Rs. 2,80,000/- (Two lakhs eithty thousands),
7. Water Pump (HP- 7)- Rs. 80,000/- (Rupees Eighty thousand),
8. Ply board (Bhutan board) 20 piece- Rs. 50,000/- (Rupees fifty thousand),
9. Cattle and Poultry animals – Rs. 5,00,000/- (Rupees five Lakhs) and
10. Other house hold properties – 15,00,000/- (Rupees Fifteen Lakhs).

The above damaged properties is estimated to worth about Rs. 34 lakhs (Thirty four lakhs).

I therefore, request to kindly taken up further legal action against the above unknowns persons.
