

Today i.e. 16/06/2023 at about 3:30 pm to 6:10 pm under the supervision of Shri Ksh Shivakanta Singh, IPS, SP-IE, a joint team of Imphal East Police led by Shri Ng. Romen, MPS, SDPO-LLI along with personnel of 2/8 GR and SSB conducted joint operation at the villages viz, Khopibung, Chalouphai, Laikot, Khamenlok and Aigejang against the Kuki militants. In that, 6(six) numbers of improvised pipe bomb gun (Bompi as local name) are found fitted at the different areas of Khopibung Village. The same are seized by observing necessary formalities. During the operation, 3(three) Nepali people who had been stuck at the villages due to the violence of Kuki Militants have been rescued from the area and kept in the safe place.

Hence, a suo motto case has been registered under FIR No. 540(6)2023 SMG-PS U/s. 506/341/307 IPC & 5 Explosive substance Act.
