


Subject:- Submission of first information report - reg.

Today, i.e 15/06/2023, when, I the undersigned went for inspection of our 6<sup>th</sup> MR personnel stationed at Leitanpokpi Bazar conflict zone, it was reported to me verbally that Hav. No.61545 Chihanpam, C-Coy of 6<sup>th</sup> MR deliberately threw away his INSAS rifle issued to him on 28/05/2023 when he ran out of bullets during a firefight of the same day. He was also reportedly drunk during the incident, the INSAS rifle number issued to him is **Butt No.53 Regn.No.18323678, the arm has not found yet.** Notably the field / team Commander Subedar P. Rockson failed to report this event to me earlier hence, the late filing of the FIR for information and necessary action please.


