


As a result many of my properties were burnt and leftover were looted. The total estimated loss properties would be above Rs. 10,00,000/- (Ten Lacs).

It is therefore kindly requested to take necessary legal action to arrest the culprit involved in the incident at the earliest in the interest of justice. I hereby lodge my complain at Kangpokpi Police Station as I had fled from my residence to safe myself and my family from those Meitei militants.




