I hereby inform that on 03/05/2023 at @ 10 pm during the ethnic problem, some unknown mob broke my gate and entered forcefully into my house at Koirengei, Imphal East. The unknown mob destroyed the properties, took away the valuable properties and finally burnt down all the remaining properties and my house. Fortunately we escaped unhurt for our livelihood. Due to the present prevailing Ethnic problem in the state, the matter could not be reported in time.

So, I therefore, request you to lodge an FIR into the matter at the earliest.


